
Passport will also perform <u>Social Security Number Verification Services</u> (SSNVS) via the SSA. Please add \$300 retail to any of the above options.


Form W2-C services - Resubmissions are billable at our current hourly support rates.

Passport will upload client-generated Electronic Filing W-2 (EFW2) files to the IRS (BSO) with notification to the client of acceptance by email. This is Federal filing only - not individual states, and does not include printed hard copy forms.


Client Responsibilities

- 1. Place order and submit payment for Proxy filing services
- 2. Client creates their EFW2 Federal magnetic media
 - a. Go to Payroll>>Year-end>>Magnetic W-2 forms.
 - b. On the selections screen, Federal files only require that the first box is checked and the correct year is entered. Click OK.






c. The EFW2 formatted text file will be in the top level of the PBS install, under the **Electronic_Media>>(year)** sub-folder. It will be named W2REPORTxx.txt, where "xx" will be the PBS Company ID. In this screenshot the year/sub-folder is "2025" and the company is "00".



d. The transmission file contains sensitive data. Do not email it to Passport. TY 2025 PSI Proxy submission for Payroll or Accounts Payable 1099s:

- Place order and submit payment for Proxy filing services. NEC and MISC are both covered and each are separate filings/submissions.
- 2. Client creates the CSV Magnetic Media
 - a. Go to Payroll or Accounts Payable>>Year-end>>Magnetic 1099 forms.
 - b. On the selection screen, enter the year, Passport's Transmitter Control Code (DBCY4), Payee information, and check the box to **Create IRIS csv files**.





c. The .csv file will be in the top level of the PBS install, under the Electronic_Media>>(year) sub-folder. The naming convention is CompanyID_FormType_Year_Date_Module_Count.csv, as in 00_1099-MISC_2025_20251201_AP_00000000.csv. Each csv file can only contain 100 forms, in other words 100 records/rows. The count is incremented by 1 for each additional file needed.

1-100 1099s	\$325
101-300 1099s	\$425
301-500 1099s	\$525
501-1,000 1099s	\$825
1.001-2.000+ 1099s	\$1625
